(c) Cash before remittance to an after drawal from bank shall be in the personal custody of the Managing Trustee and he shall be personally responsible for its safe custody. However joint custody with double lock arrangement with some paid employees may be made if needed, by a specific resolution of the Board of Trust.

(d) All expenditure shall be subject to approvals as per budget scheme or programme provided in the case of urgency not covered in budget as felt by the Managing Trustee and Asst. Managing Trustee with previous approval of the Board of trust shall have the power to sanction expenditure to the extent of Rs.10,000/- (Rupees Ten Thousand only) for such an urgency to be subsequently covered under regular supplementary budget scheme programme to be approved by the General Body in its next regular meeting or before the expiry of six calendar months from the date of such special sanction in an urgent meeting of the General Body whichever is earlier.

(e) Surplus income each year shall be added to a Reserve Fund for meeting the basis needs of the Trust touching its foundation or would be kept in fixed deposit scheme with any Nationalized bank or Banks inside Odisha.

The Trust being a Non-Trading and Non-Profit making Trust the Office bearers shall manage the affairs prudently and diligently and in a manner not to incur any loss which is unintentional, unavoidable and is not a case of misappropriation there shall be written by the Managing Trustee and where such loss is due to the negligence or is due to a case or proved misappropriation personal responsibilities is to be fixed and suitable legal action may be taken for recouping such loss along with lost thereof as per the Valid resolution of the Board of trust.

Any act done by any member of the Trust in contravention of any previous of these Bye-laws shall be treated as being done against morals of the Trust and such acts shall put such member or members in a position the membership being ceased as per the provisions of this Bye-law and such acts of such members shall not be treated as acts of the Managing Trustee.

11. DISSOLUTION :

The scope and activities of the Trust may be extended to all the villagers within the Indian Territory

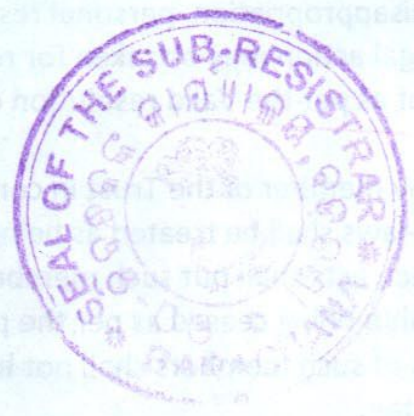
